## 1. Welcome & adoption of the agenda

The co-chairs of the meeting welcomed the participants and introduced the Agenda for adoption.

## 2. ENCePP Workplan

Catherine presented the final draft of the ENCePP workplan that was updated by the co-chairs following the SG kick-off meeting in February, and circulated for review by SG members prior to this meeting.

- The revised **ENCePP mandate** adopted earlier this year has been updated on the ENCePP website. The updated **SG mandate** also adopted will be published after the meeting.
- Prior to the SG meeting, the ENCePP co-chairs discussed with the Working Groups chairs the need to update the mandates of the current WGs, and to revise the governance of the WGs. In addition, creation of potential new WGs to better reflect the ENCePP workplan was discussed. The SG agreed to develop terms of reference for the WGs, incl. chairing, membership, mandate, and timeframe. Participation of industry representatives in the WGs was raised and will be discussed at Secretariat level.

### ACTIONS

- **WG chairs** to finalise the update of their mandates and share with the Secretariat for review by the SG (asap)
- Volunteers to develop terms of reference for the WGs (and SIGs) for discussion and adoption at the September SG meeting: Helga Gardarsdottir, Gianmario Candore, Laura Pizzi
- **Communication activities** to support **increasing the impact of ENCePP** include the publication on the website of news items, events, and slide decks; podcasts; use of social media; and reaching out to the larger PV/PE community.

### ACTIONS

- Drafting of categories/criteria for publication on the ENCePP website: **Vera Ehrenstein**
- Slide deck on ENCePP: Catherine Cohet to share a proposal for the SG to review
- First podcast "Conduct your study" by WG2 to be posted on the website (Post-meeting note: posted on 12 June: <u>Launch of the ENCePP 'Conduct your study' podcast series</u>)
- Julianna Fogd to check possibility of an ENCePP LinkedIn account with the EMA Communications team
- Julianna Fogd to check with DIGIT (host of the ENCePP website at the European Commission) the possibility of activating the RSS feed on the ENCePP website to allow website users to stay up to date. Example: <u>RSS feeds | European Medicines Agency</u> (Post-meeting note: DIGIT is now checking this query)
- Catherine Cohet & Laura Pizzi to investigate options for an ENCePP session at the <u>ISPOR</u> EU conference in November, in addition to the ICPE symposium/workshop (see agenda topic 4).

The final adopted workplan will be published on the ENCeP website by the end of June.

## 3. Update on the qualitative survey

Helga gave an update on the qualitative study on the value and future role of ENCePP, which is currently being conducted by Shar Rao, master's student at the University of Utrecht (UU), with the involvement and supervision of the ENCePP SG co-chairs, Helga Gardarsdottir (UU) and Catherine Cohet (EMA). The project is divided into two parts: Part 1: Qualitative interviews, and Part 2: Questionnaire. In Part 1, which focusses on current and future role of ENCePP, the design of the study has been completed (February-April 2024), and stakeholder engagement has started. Part 2 will focus on assessing use of ENCePP tools and guidances.

Question on the involvement of PRAC assessors as stakeholders: Helga confirmed that for the interviews they have not been involved, but will be included for the survey.

**ACTION: Ulla Wändel Liminga** and **Annette Cleveland Nielsen** to further reflect on participation of EMA Committees to the survey given the different levels of knowledge of ENCePP and ENCePP tools among the committees, and consider proposing potential names for interviews.

## 4. ENCePP symposium/workshop at ICPE

Catherine gave an update on the ENCePP symposium/workshop accepted by <u>ICPE</u>, sponsored by the ISPE <u>Real-World Evidence Collaborative</u>. Title: '15+ years of ENCePP: What has been achieved, what's next, and what's in for ISPE.'
