1. Welcome & adoption of the agenda

Objective 3.1 – The topic was covered in the 2024 ENCePP Plenary meeting, and further details are included in agenda topic 5 below.

Objective 3.2 – The SG agreed that it would be more feasible and effective to replace the term "cobranded events" by "engagement" (e.g., to develop webinars and other joint acitivites such as presenting the ENCePP tools, for example at ICPE 2026). Gianluca Trifiro suggested to explore the possibility of a webinar or apresentation at ISoP 2025 in collaboration with the ISoP Big data SIG.

Objective 3-4 – See section 3 of the minutes below.

Objective 3.5 – This was started in 2024, the first countries are registered as institutions and ENCePP partners in the HMA/EMA RWD Catalogues.

3. Working groups (WGs)/ Special interest groups (SIGs)

Catherine Cohet summarised the discussions held in previous SG meetings and the ENCePP Plenary on the reformation of the ENCePP WGs and SIGs – i.e., the development of Terms of Reference (ToR) for

the WGs and SIGs, and the creation of new groups to implement the ENCePP workplan. The ToR document was developed in collaboration with, and approved by the SG.

ACTION for EMA: to publish the ToR document

Post-meeting note: the <u>ToR document</u> and the '*Template for ENCePP WG and SIG proposal'* are now published on the Working Groups and Special Interest Groups page of the ENCePP website.

3.1. Process

The SG agreed that there should be a clear and transparent decision-making process, including SG critical review of all proposals. It is important that all proposed objectives are realistic and achievable, with timelines and deliverables clearly defined, while avoiding overlap between WGs and SIGs. It was clarified that the WGs should not create SIGs for delivering their tasks. The SIGs should be separate entities from WGs with their own objectives. The groups are expected to manage their work, as the EMA Secretariat cannot be involved in all activities.

The SG will monitor the progress of each WG/SIG and propose, when the deliverables are fulfilled, that the groups are closed.

This new process will be evaluated in a year time to assess how it worked and whether any changes are needed.

3.2. Discussion on proposals for new WGs/SIGs

As an appreciation of their past work, the chairs of the <u>previous WGs</u> were asked first by the SG cochairs to send proposals for new groups, taking into account activities that they feel should continue.

The SG reviewed the list of topics proposed in Plenary and agreed on a shortlist for the creation of new WGs/SIGs, in line with the work plan and current environment:

- Update of the **Checklist for Study Protocols**: This is a clear need in the context of new developments such as HARPER and the revision of GVP Module VIII. Work as already started, led by members of the former WG1 and will be delivered under a **SIG**.
- **Communications**: As this is a broad scope, the focus of this **WG** would be on expanding the podcast series, and address other topics of the workplan, such as webinars as useful tools to reach out/engage/educate, proposals for news/events items on the website, patient engagement activities, link with learned societies etc. as well as coordination with the various WGs/SIGs to communicate on their deliverables
- Revision of the ENCePP Guide: As it represents continuous work overtime (the editor and the authors are expected to follow current trends and developments on each topic in order to propose updates), it will be a WG, open to new members. The first task should be to develop a strategy for updating the Guide including frequency of revisions, timelines, process for selecting chapters for update, etc. The SG agreed that as it is a significant piece of work (including on EMA's side), it is not feasible to update all chapters on a regular basis (or annually, as done until 2023).
- **Code of Conduct** (CoC): while the need for a focused update is acknowledged, no major revision is required. Discontinuation of the ENCePP Seal (see agenda topic 4 below) will have to be reflected. However, it is not expected that regular updates of the CoC are required.
- **AI** A majority of SG members highlighted that artificial intelligence (AI) is a 'hot topic' impacting pharmacoepidemiology, and would deserve a SIG or WG; however, no specific objectives were mentioned. Suggestions for activities included: update of the AI chapter of the Guide; building a repository of use cases; listing/assessing tools for protocol/report writing; screening the HMA/EMA

Catalogue of RWD studies for use of AI; linking with the EMA Reflection paper on the use of Artificial Intelligence (AI) in the medicinal product lifecycle and EMA AI workplan.

Suggestion from the FDA representative: FDA could contribute uses cases for pharmacoepidemiology and learnings thereof: Considerations for the Use of Artificial Intelligence To Support Regulatory Decision-Making for Drug and Biological Products | FDA.

- Diversity/health equity in pharmacoepidemiology: Proposal for a SIG has been received, including amongst other a deliverable on how diversity/health equity can be reflected in the ENCePP Guide. E.g., diversity in clinical studies: <u>Diversity Action Plans to Improve Enrollment of Participants from Underrepresented Populations in Clinical Studies | FDA</u>
- **Pragmatic trials**: An important topic, with identified gaps such as terminology and data challenges, also reflected in the workplan of the EMA Methodology Working Party. This could be a SIG, with for example update the PCT chapter of the Guide as a deliverable.
- Engaging with Central/Eastern Europe countries, e.g., to assess national data sources: This
 could be a SIG or a deliverable of the Communication WG. Vera Ehrenstein, Helga Gardarsdottir
 and Irina Vlasenko are interested.
- Proposals from the chairs of the former WGs 1, 2 and 3 were received by the Secretariat and will be evaluated as part of the review of all proposals (see Next steps below).

The SG agreed to not create new groups on the following other topics that were suggested in Plenary:

- Target trial emulation: this is addressed by the EMA <u>RWE Reflection paper</u>, Chapter 4.2.6 of the ENCePP Guide, and ongoing initiatives by different stakeholders, therefore duplication was not considered of immediate benefit.
- Digital pharmacovigilance: no clear objectives could be identified.
- Rare diseases: while this was considered an important topic in terms of method and data source challenges, it was felt that it is covered by several topics in the ENCePP Guide, but could be considered at a later stage.
- Data protection and privacy: there is already a chapter in the ENCePP guide.
- Impact of PV activities: there was already a <u>SIG on Measuring the Impact of Pharmacovigilance</u>

 <u>Activities</u>, now closed as deliverables were completed, and the topic has been regularly updated as part of the revisions of the ENCePP Guide (Chapter 16.4).

3.3. Next steps

- SG to provide final endorsement of the short list of WGs/SGs as per these minutes.
- EMA to invite ENCePP Partners to express interest to join the above proposed WGs/SGs within one month (considering the ToRs). The template will be included in the email communication. Engagement of junior partners is encouraged, as ENCePP would benefit from fresh, creative ideas (e.g., PhD students with high motivation, who would also benefit from the deliverables).
- A special SG meeting dedicated to review of all proposals will be scheduled by end of Q1.

4. (Dis)continuation of the ENCePP Seal

The discussion on decommissioning the ENCePP Seal has been ongoing for several years with previous Steering Groups. There is no legal basis for the Seal to be taken into account in the assessment of protocols and reports by EMA Committees, and limited awareness and perceived added value. In addition, the number of applications since its inception is very low, potentially suggesting limited added value for MAHs as well.

Based on the above, the SG agreed to discontinue the ENCePP Seal. It was clarified that individual components of the Seal remain key.

ACTIONS:

- EMA to draft a statement on behalf of the SG for announcement on the ENCePP website.
- The change should be reflected in relevant documentation and systems (e.g., ENCePP website, HMA-EMA Catalogues).

5. Qualitative research - next steps

The results were presented at the Nov. 2024 ENCePP Plenary meeting. A report was developed by Shar Rao for her master thesis. The SG agreed that the findings would deserve to be communicated. Proposals from the SG included an IPCE abstract submission, and a webcast (similar to the ENCePP Plenary presentation) to be published on the ENCePP website.

ACTION: Helga Gardarsdottir to investigate the possibility of the above two suggestions.
